**NOTIFICATION**

**Subject: Revision of Labelling Guidelines in MTCTE Procedure- reg.**

The Labelling Guidelines with reference to TEC Certification Label notified vide MTCTE Procedure V2.1 TEC 93009:2021 read with this office O.M. No. 5-10/2021-TC/TEC dated 07.09.2021 (copy enclosed), are modified as below:

**Clause 9.1 (iii)**

Relevant TEC Certification label (TEC Logo along with MTCTE followed by Certificate Number).

**Clause 9.1 (iv) - Deleted**

**Clause 9.2**

Requirement of labelling on certified products shall be exempted for initial period of six months w.e.f. date from which testing and certification of respective equipment in India is notified as mandatory or six months from the date of issue of MTCTE Certificate, whichever is later. The detailed labelling guidelines are given in Annexure-D.

**Clause 3.2 of Annexure-D**

The height of the TEC logo shall be  $1/4^{\text{th}}$  of the size of the brand name on the product, subject to a minimum height of 6 mm. However, if size of brand name is less than 6 mm due to space constraint, then height of the TEC logo may be kept as size of brand name.

**Clause 4.0 of Annexure-D**

The 'TEC certification e-label/ physical label' consist of TEC Logo along with MTCTE followed by the Certificate Number as given in the below figure:




**MTCTE: xxxxxxxxxx**

xxxxxxx:- denotes the certificate number issued by MTCTE portal (9 digit).

2. Further, TEC certification label in accordance to previous O.M. No. 5-10/2021-TC/TEC dated 07.09.2021, already affixed on the product will remain acceptable.

**Subject: Revision of Labelling guidelines in MTCTE Procedure**

The Labelling Guidelines with reference to TEC Certification Label notified vide MTCTE Procedure No. TEC 93009:2021 released in May 2021, have now been revised as below:

**Clause 9.1 (iii)**

“Relevant TEC certification label (India, Certificate No., TEC Logo and address of MTCTE Portal of TEC)”.

**Clause 4.0 of Annexure – D:**

“The ‘TEC certification e-label / physical label’ consists of the Name of Country “INDIA”, Certificate No., TEC Logo and the address of MTCTE Portal of TEC as given in following figure:



In case sufficient space on parts, items or product is not available for marking labelling information, at least Country Name (‘India’) and TEC Logo to be marked and rest of the information w.r.t. above shall be provided in the form of machine-readable i.e. two dimensional code (QR code etc.)”

2. Further, the relaxation/exemption period for enforcement of labelling guidelines notified vide MTCTE Procedure (Ver 2.1 Rel. May 2021) on certified telecom / related ICT products issued vide Office Memorandum No. 5-3/2021-TC/TEC dated 17.05.2021 is revised from 30.11.2021 to 31.05.2022. Therefore, it shall be mandatory to comply with the revised labelling guidelines from 01.06.2022 onwards.
